

Medical/Surgical Prime Vendor (MSPV) is a national program that provides an efficient and cost effective method for ordering and distributing medical, surgical, dental, and select prosthetic and lab supplies across VHA facilities by:

MSPV-NG Bridge Transition Overview

As of: 3/24/2020

MSPV-NG Bridge will ensure continuity of services between expiration of current MSPV-NG Prime Vendor (PV) contracts and full MSPV 2.0 implementation, given no additional protests.

Key MSPV-NG Bridge Facts

- MSPV-NG contract expires 3/31/2020
- The MSPV-NG Bridge will be in place from 3/2020 until a date not to exceed 3/2021
- Facilities will be allowed to order from ECAT and GPC when items are not available via MSPV-NG Bridge Formulary

Distribution Contracts

- MSPV-NG Bridge Prime Vendor (PV) contracts were awarded 3/13/2020
 - Current PV service areas will not change with the transition to MSPV-NG Bridge contracts
- The MSPV-NG Bridge transition is on track to be successfully implemented by 4/1/2020




Supply Agreements

- Fair and reasonable determinations were conducted on pricing review for over 15,700+ items
 - Of those, less than 7% were identified as discontinued or not having fair and reasonable pricing
- More than 20,000 items will be on the Bridge Formulary, very similar to the MSPV-NG Formulary


